Release and Agreement Not to Sue

In consideration, I the undersigned, does hereby represent that he/she (they) is (are), in fact, acting in such capacity and agrees to indemnify, save and hold harmless each and all of the parties herein referred to above as Releasee's from all loss, liability, damage, cost or claim whatsoever that may be imposed upon said Releasee's because of any danger, risk or hazard and the possibility of personal injury, property damage, death or loss resulting thereof.

RELEASE OF LIABILITY, WAIVER OR CLAIMS, AND INDEMNITY AGREEMENT:

Being able to participate in all activities of the KMS Memorial Ride, I the undersigned, agree as follows:

1. My participation in activities and events organized by the KMS Memorial Ride is voluntary.
2. I am aware that there are risks to my personal safety or property, including the risk of serious injury and/or death in conjunction with my participation in this event. I assume all risks associated with my participation in any events organized or sponsored by the KMS Memorial Ride or connected with the KMS Memorial Ride, including death or injuries to person, damage or loss to property.
3. I do hereby, for myself, my heirs, administrators, executors, guardians, assigns, representatives, and next of kin, forever WAIVE, RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the KMS Memorial Ride (all of whom are referred to as the Releasee's), its members and each of their respective affiliates, officers, directors and agents, and/or their respective representatives, officers, directors, employees, agents, successors, and assigns (collectively, the "Releasee's"). I further agree to indemnify, defend and hold harmless Releasee's from any loss, liability, cost, claim or damages arising from my participation in or association with any events organized and sponsored by the KMS Memorial Ride or connected with the KMS Memorial Ride.
4. I consent to administration of first aid and other medical treatment in the event of injury and release and indemnify Releasee's from any and all liability or claims arising out of such treatment.
5. I hereby grant full permission to Releasee's, as described above, to use any photographs, images, videotapes, motion pictures, recordings, or any other record of the activities of the above named event for any legitimate purpose. All photographs or other submissions taken by or given to the KMS Memorial Ride shall be the property of the KMS Memorial Ride
6. By signing this document, I consent that if I am the driver that I hold a valid driver's license w/motorcycle endorsement, and current insurance. I will not become intoxicated while driving a motorcycle or any vehicle in accordance with the laws of the State of MN. I understand that if I should become intoxicated while operating a vehicle on MN streets or highways during this event, that I may be asked to leave by any Board of Directors member of the KMS Memorial Ride. I agree to do so of my own free will. I agree if I pose any safety risk that I may be turned away from this ride.
